Collecting data

We collect data if you:

- make a reservation request
- direct booking
- you sign up for the newsletter

We only use the information you provide us. This can be the following information: '

- your first and last name
- Evt. First and last names of your fellow travelers
- Your email address
- your adress
- your telephone number
- Amount of adults
- number of children
- birth dates

We need this information to properly handle and respond to your request.

What do we use the data for?

data is collected and stored for the following purposes:

- The reservation request with the requested data we need to check the availability of a suitable holiday home for you.
- We use your name and email address for sending newsletters. This is done exclusively with the information we have received via the request for a reservation and / or registration of the newsletter.

Data that we store

These are the data that we store:

- First and last name
- Address, postal code and town, so that we can address your reservation confirmation as quickly and easily as possible to the right person and to the right address.
- Telephone number, to be able to inform you about your request or to pass on modified information about your holiday home at the last moment. Sometimes it is more convenient to do that by telephone. You are never obliged to fill in.
- Email address, because as soon as we have received your request for a holiday home, you will receive a confirmation by email.
